

# Online Privacy Statement

This Online Privacy Statement applies to your use of the CleanPeak Energy internet website under the domain name cleanpeakenergy.com.au.

This Online Privacy Statement is provided to make you aware of how CleanPeak Energy Pty Ltd (ABN 85 169 761 648) collects, uses and manages information of visitors to the Website. CleanPeak Energy considers as important your personal privacy and the protection of your personal information.

## **What Information Do We Collect and How Do We Use It?**

CleanPeak Energy collects the following information regarding visitors to its website, and information regarding what pages are accessed. CleanPeak Energy collects and logs this information for statistical purposes. Other than as stated above, no attempt is made to identify you or your browsing activities except, in the event of an investigation, where a law enforcement agency may exercise a warrant to inspect the service provider's logs, or where your usage is causing technical issues for our site that may need to be resolved and we need to contact you.

Some sections of this Website may also allow you to contact us by email or otherwise volunteer information about yourself, such as your name, email address, employment application details, survey responses, and your preferred means of communication. In addition to the purposes outlined above, this information may be used and disclosed for the purposes of carrying out or responding to your requests, for purposes relating to any third party acquisition or potential acquisition of an interest in CleanPeak Energy or its assets, or any other purposes outlined at the time you provide the information. We may not be able to do these things without your personal information. For example, we may not be able to contact you or offer employment to you.

CleanPeak Energy may disclose your personal information to our related bodies corporate and to service providers who assist us in providing this Website and conducting our business including organisations that provide archival, auditing, professional advice, mail house, delivery, recruitment, technology, utility and security services.
